
CERTIFICATE OF NON-REVOCATION OF POWER OF ATTORNEY

## DEED OF DELEGATION

DEED dated this 18<sup>th</sup> day of October 2024

### PARTIES

1. **THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF HAMILTON** in his capacity as corporation sole (**Bishop**)
2. **GREGORY DAVID SCHMIDT (Diocesan General Manager)**

### BACKGROUND

The Bishop wishes to delegate certain rights, powers, and privileges to **Gregory David Schmidt**, the Diocesan General Manager.

The Diocesan General Manager understands the Bishop's intentions and instructions and accepts the delegation of authority on the terms set out in this Deed.

### THIS DEED WITNESSES

**Richard Philip James Laurenson**, Roman Catholic Bishop of the Diocese of Hamilton, New Zealand, in exercise of the powers contained in section 23 of the Roman Catholic Bishops Empowering Act 1997 (**Act**) hereby;

**DELEGATES** to **Gregory David Schmidt**, the Diocesan General Manager, the rights, powers and privileges vested in or belonging to him as Bishop, including the power to use the seal of the Bishop. These rights and powers include (but are not limited to); the authority to execute and approve any Deeds or Documents (whether or not intended for registration under The Land Transfer Act 2017), individual Employment Agreements, and reports and certificates required under the Deed of Amendment and


Reinstatement of Trust Deed dated 23 November 2016 between the Issuer and the Roman Catholic Bishop of the Diocese of Hamilton (as the Catholic Development Fund) and the Supervisor, Covenant Trustee Services Limited.


**DECLARES** that the authority conferred by this Deed does not extend to powers of delegation or the powers conferred on him by part 4 of the Act.

The parties agree that this delegation will cease upon the earlier of the following:

- (a) its revocation by the Bishop or
- (b) Gregory David Schmidt ceasing to hold the position of Diocesan General Manager.


